Report from the Principal – Kristen Stone

1. Enrollment – 218 students currently enrolled. Lost 3 students to homeschooling. Students were replaced.

- 2. January Plan for Reopening-
 - Mrs. Stone reported that by Governor's orders we can reopen with all students K-5 attending each day. Tanner Smith asked for a survey to be completed by parents to see the interest in coming back. He wants information by grade level and total percentages. Scot McLean expressed that student students needed to be back in school. Discussion went on about safety of students and staff. If it was feasible under the guidelines. Motion was made to meet again the first Tuesday in January, in a special meeting to look at the data at that time. All in favor. The motion carried. Mrs. Stone would send out the survey and have the data by the time we meet at the special meeting in January.
- 3. Beginning Teacher Support Plan- Mrs. Stone presented the Beginning Teacher Support plan with the new section on Beginning Teacher's having to take a required survey after their first three years teaching. Mrs. Stone explained that this was a Legislative mandate. No questions were made. Motion was made to approve and motion carried.
- 4. Athletics- Mrs. Stone explained that SeA would have a boys and girls basketball season. All guideline set by the league would be followed.

Finance and Repair Update -

 Mrs. Tanya Branch Reported that we are within Budget. There will be extra money available and some of the funding will be used for repairs needed in the building.
 She would be getting quotes to present at the next finance meeting in January.
